PURPOSE

The S. C. Society of Professional Land Surveyors (SCSPLS) was formed to advance the public welfare and the professional, social and economic interests of the Registered Land Surveyor by promotion of education, legislation and public relations through the establishment and maintenance of high ethical standards and practices. It is proposed to bring about coordination between the Land Surveying and Engineering Professions through close cooperation with representative organizations of Professional Engineers.

MEMBERSHIP CATEGORIES

SCSPLS Membership year is from July 1 through June 30 of each year.

\$165.00 per year for Full members plus \$10.00 application fee = \$175.00

\$200.00 per year for Sustaining members plus \$10.00 application fee = \$210.00

\$ 65.00 per year for Associate members plus \$10.00 application fee = \$75.00

\$ 10.00 Complimentary application fee

\$ 25.00 per year for dues for Student members, Application fee waived = \$25.00

FULL MEMBERS

Professional Land Surveyors who are of good standing in South Carolina or any state or territory of the United States that regulates the practice of land surveying and the licensing of Registered Land Surveyors.

Annual Dues: \$165.00. Application fee: \$10.00.

ASSOCIATE MEMBERS

Land Surveyors in Training and any person who is working toward registration as a Land Surveyor and has not qualified for the exams may become an Associate Member of the Society. Associate members shall have all rights and privileges of membership except the holding of office or balloting in the election of officers.

Annual Dues: \$65.00. Application fee: \$10.00

SUSTAINING MEMBERS

Any commercial or professional institution or individual interested in surveying and mapping, the manufacture of instruments or equipment for this work or the production or compilation of maps. Sustaining members shall have all rights and privileges of full membership except the holding of office and voting.

Annual Dues: \$200.00. Application fee: \$10.00

EMERITUS MEMBERS

Any member who has reached the age of 65 and has been in good standing for 15 or more consecutive years with the SCSPLS may apply for Emeritus Membership subject to approval by the Board. Emeritus members have all rights and privileges of full membership.

Annual Dues: Exempt.

HONORARY MEMBERS

The Board may bestow upon any person, who has rendered acknowledged eminent service and who has made valuable and outstanding contributions to the profession, the title of Honorary Member. Honorary members shall have all rights and privileges of full membership except the holding of office and balloting in the election of officers.

Annual Dues and Application Fee: Exempt.

STUDENT MEMBERS

Any student of a school of higher education recognized by the Board of Directors who is interested in Land Surveying or related professions. Student members shall not be eligible to vote or to hold office in the Society.

Annual Dues: \$25.00. Application fee waived.

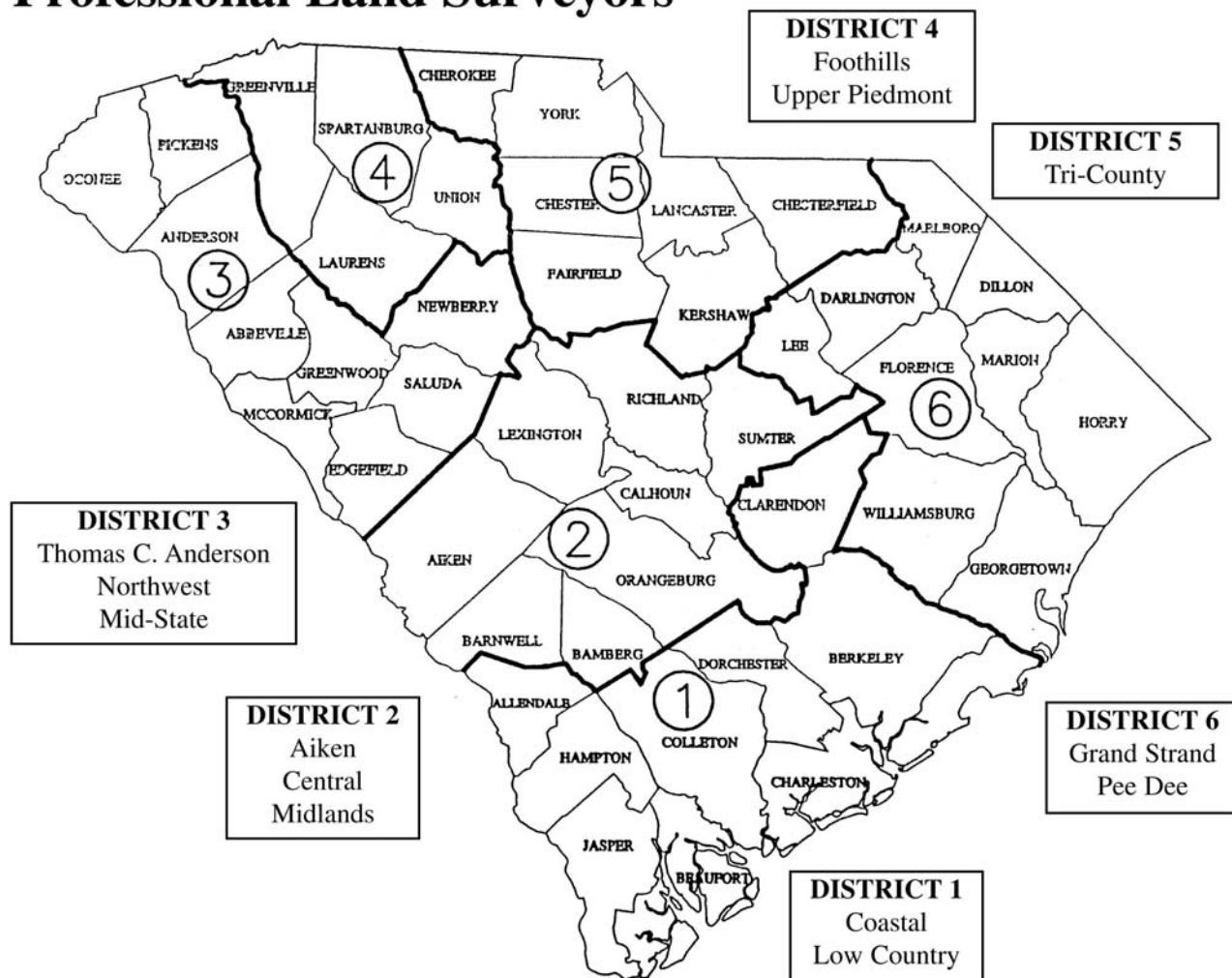
